BOROUGH OF NORTH CALDWELL, ESSEX COUNTY

AN ORDINANCE AMENDING AND SUPPLEMENTING VARIOUS PROVISIONS OF CHAPTERS 45 AND 71 OF THE CODE OF THE BOROUGH OF NORTH CALDWELL CONCERNING FIELD USE FEES

WHEREAS, the Governing Body has reviewed the Code of the Borough of North Caldwell and finds it to be in the best interest of the Borough to amend the regulation of athletic field use fees; and

NOW, THEREFORE, BE IT ORDAINED By the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. Chapter 45, \$45-1 of the Code of the Borough of North Caldwell be and is hereby amended as follows:

- 2. Chapter 71, §71-2 of the Code of the Borough of North Caldwell be and is hereby amended as follows:
 - § 71-2, Permit for group activity.
 - E. Fees for the use of Borough facilities may be charged pursuant to fee ordinances which may be adopted by the Borough. Fees for the use of Borough fields will be charged as follows:

- (1) Liberty Turf Field Use Fees.
 - (a) All Borough Recreation Department sports, activities or events shall not incur a field use fee regardless of sport, season, or field.
 - (b) All in-town travel teams will pay a use fee as
 follows:
 - [1] In-season use fees shall be \$25 per player per season;
 - [2] Off-season use fees shall be \$35 for two hours of permitted use. An additional \$35 is required for an additional two hours of permitted use.
 - (c) Outside organizations will pay an hourly use fee as follows:

 - (b) All in-town travel teams will pay \$100.00 per team for the season regardless of season.
 - (c) All out-of-town travel teams will pay \$200 per team for the season regardless of season.
 - (d) Outside organizations will pay an hourly use fee as follows:
