- 3. All ordinances or parts thereof inconsistent herewith are hereby repealed.
- 4. This Ordinance shall take effect immediately upon adoption and publication according to law and upon the execution of a Collective Bargaining Agreement by and between the Borough of North Caldwell and West Essex PBA Local 81, effective January 1, 2021, with retroactive compensation authorized to be paid upon execution of said Collective Bargaining Agreement and final adoption of this Ordinance.

This agreement is effective as of January 1, 2021 and with retroactive compensation to be paid subsequent to the adoption of this ordinance.
