BOROUGH OF NORTH CALDWELL, ESSEX COUNTY

AN ORDINANCE AMENDING §99-3D-1 OF THE BOROUGH CODE OF THE BOROUGH OF NORTH CALDWELL REGARDING TEMPORARY PARKING TIME LIMIT ON HILLSIDE AVENUE

WHEREAS, the first 100 feet of the south side of Hillside Avenue, starting from the corner of Hillside Avenue and Main Street, and extending to the beginning point of the driveway at the property designated as 707 Main Street, is designated as a temporary drop off zone and is posted as such; and

WHEREAS, the Borough of North Caldwell wishes to specify a time limit on said temporary parking zone; and

WHEREAS, the Chief of Police recommends that temporary parking be limited to two (2) hours.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of North Caldwell, in Essex County, New Jersey, that:

1. Chapter 99, Section 3d-1 of the Borough Code regarding temporary parking zones on Hillside Avenue be amended as follows::

§ 99-3 Parking prohibited at all times on certain streets; handicapped parking zones; fire zones; resident permit parking zones.

D. Resident Permit Parking Zones.

Hillside Avenue

(1) The first 100 feet of the south side of Hillside Avenue, starting from the corner of Hillside Avenue and Main Street, and extending to the beginning point of the driveway at the property designated as 707 Main Street, shall be designated as a temporary drop off zone *for a two (2)-hour time limit* and shall be posted as such.

2. Any article, chapter, section, paragraph, subsection, clause, or other provision of the Borough Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.
3. In case, for any reason, any portion or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other portion or provision of this Ordinance, except so far as the portion or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.
4. This Ordinance shall be part of the Code of the Borough of North Caldwell as though codified and fully set forth therein. The Borough Clerk shall have this Ordinance codified and incorporated in the official copies of the Code.
5. This Ordinance shall take effect immediately upon publication and final passage according to law.
