Mayor and Council Regular Meeting - March 22, 2022

The Regular Meeting of the Mayor and Council of the Borough of North Caldwell was held on Tuesday, March 22, 2022. The meeting began at 6:30pm at Borough Hall and was held simultaneously via tele/video-conference.

Mayor Alessi called the meeting to order announcing that notice was provided in accordance with the requirements of Chapter 231, P.L. 1975. He provided a statement regarding the conduct of the teleconference which would allow members of the public to participate and be heard during public comment.

Councilman Matthew Atlas and Councilman Anthony Floria-Callori joined the meeting at 6:35pm.

Mayor Alessi asked Council President Astorino to lead the Pledge of Allegiance.

### **Mayor's Report**

Mayor Alessi stated that flags were raised in town as a sign of support for the people of Ukraine. He announced the pledge of \$300,000 to North Caldwell from the Federal Spending Bill for security of certain infrastructure in town. He wished everyone a Happy Easter and Happy Passover.

He noted that pool restoration and slide installation were among the improvements.

# Ordinance O-8-2022

Councilman Atlas introduced Ordinance O-8-2022 An Ordinance Amending §45-1 Regarding Animal Control Fees. He noted that a new fee structure would transfer the cost of sheltering and other services from the Borough to the pet owner. He noted that the public hearing would be held on April 26, 2022 at 6:30pm. Councilman Atlas made a motion, seconded by Councilman Kessler. Said motion was carried unanimously with six (6) affirmative votes.

Resolution R-60-2022 A Resolution Authorizing the Award of a Professional Services Contract Between the Borough of North Caldwell and Integrated Aquatics Engineering for Municipal Pool Improvements Engineering and Design Services was read. Councilman Atlas noted the contract was for professional services and made a motion, seconded by Councilman Kessler. Councilman Tilton voted no. Said motion was carried with five (5) affirmative votes.

# **Personnel and Technology**

Councilman Floria-Callori reviewed progress made with V-Comm regarding potential locations for telecommunication improvement infrastructure sites. He announced the implementation of the CivicRec site for recreation program and sports registrations.

Motion was made by Council President Astorino, seconded by Councilman Atlas. Said motion was carried unanimously with six (6) affirmative votes.

# **Public Safety**

Councilman Tilton presented the Police Department Public Safety and Detective Bureau Reports for February 2022. He noted that 726 calls were received by Dispatch with 51 tickets issued. He noted that NCPD is working with the Essex County Sherriff's Office to thwart motor vehicle thefts.

Councilman Tilton presented the Fire Department Public Safety Report for February 2022 during which there were 17 calls and one response for mutual aid to Cedar Grove. He reminded all to change batteries in smoke detectors. He announced the NCFD pancake breakfast on June 5 and the department's 100<sup>th</sup> anniversary celebration on September 24.

Resolution R-69-2022 A Resolution Approving the North Caldwell Volunteer Fire Department Certified LOSAP List for the Year 2021 was read. Motion was made by Councilman Tilton, seconded by Councilman Kessler. Said motion was carried unanimously with six (6) affirmative votes.

### **Public Works**

Councilman Rees presented the Construction Permit Activity Report for February 2022 during which 25 permits were issued, with a total of 57 permits issued in 2022 to date.

Councilman Rees presented the Animal Control Report for January and February 2022.

Resolution R-70-2022 A Resolution Fixing Water Rates Pursuant to Ordinance O-1-09 was read. Motion was made by Councilman Rees, seconded by Councilman Atlas. Said motion was carried unanimously with six (6) affirmative votes.

Resolution R-71-2022 A Resolution Accepting a Bid and Awarding a Contract for Mowing and Trimming of Municipal Facilities within the Borough of North Caldwell was read. Motion was made by Councilman Rees, seconded by Councilman Atlas. Said motion was carried unanimously with six (6) affirmative votes.

Resolution R-72-2022 A Resolution Authorizing the Execution of an Interlocal Agreement with the Township of West Orange for Animal Facility Sheltering Services was read. Motion was made by Councilman Rees, seconded by Councilman Atlas. Said motion was carried unanimously with six (6) affirmative votes. Councilman Rees stated that residents can obtain free rabies vaccinations for their pets at the shelter.

## Recreation

Councilman Kessler presented the Recreation Director's Report for March/April 2022. He announced the end of the Recreation Basketball season and the start of the Recreation Baseball/Softball season including Men's and Women's softball leagues. He noted the transition to CivicRec for program and sports registrations. Councilman Kessler welcomed Seniors to the April 6<sup>th</sup> meeting and luncheon during which blood pressure screenings would be available. He announced job opportunities at the Municipal Pool and within the Summer Fun Camp program for the summer months. He noted that Baseball/Softball Opening Day was scheduled for April 30<sup>th</sup>.

Councilman Kessler presented the Camp Wyanokie Report for January/February 2022. He announced an Open House event on June 18<sup>th</sup>. He reviewed a report from NJDEP regarding the safety of a dam on the property which requires repair. He noted that revenue has increased to over \$100,000 over the last two years.
