Mayor and Council Regular Meeting - April 25, 2023

The Regular Meeting of the Mayor and Council of the Borough of North Caldwell was held on Tuesday, April 25, 2023. The meeting began at 6:41p.m. at Borough Hall and was held simultaneously via tele/video-conference.

Mayor Raymond called the meeting to order announcing that notice was provided in accordance with the requirements of Chapter 231, P.L. 1975. He provided a statement regarding the conduct of the teleconference which would allow members of the public to participate and be heard during public comment.

Roll Call indicated the following:

Present: Mayor Joshua H. Raymond, Council President Floria-Callori, Councilman Matthew Atlas, Councilman Robert Kessler, Councilman Arthur Rees, Councilman Kenneth Tilton and Councilman Stephen Weinstein.

Also present were: Kevin O'Sullivan, Borough Administrator; Jarrid Kantor, Borough Attorney; Rich Mondelli, CFO; Karl Strodthoff, Police Chief; and Tami Michelotti, Borough Clerk.

Mayor Raymond asked Councilman Rees to lead the Pledge of Allegiance.

Mayor Raymond recognized Essex County Liaison Maya Lordo who was present. Ms. Lordo welcomed all to the State of County Address scheduled for Thursday, May 27, 2023 at 6:00p.m. She announced the latest COVID vaccine guidance from the CDC and the availability of boosters. Ms. Lordo confirmed the end of the public health emergency as of May 11, 2023.

Mayor's Report

Mayor Raymond announced the submission of a grant application, championed by Congresswoman Sherrill, to enhance safety and protection against vehicle thefts. He announced the approval of a grant for the rehabilitation of the restrooms at Liberty Park. Mayor Raymond stated that bids were received for the cell tower construction at Mountain Avenue and Skyline Drive. He announced the annual NCFD Pancake Breakfast to be held on June 6, 2023 and thanked all who participated in the Earth Day Celebration and clean-up.

2023 Municipal Budget Hearing

Mayor and Council Regular Meeting - April 25, 2023

Councilman Weinstein made a motion, seconded by Councilman Atlas, to approve Resolution R-90-2023 A Resolution Authorizing the Reading of the 2023 Municipal Budget by Title. Said motion was carried unanimously with six (6) affirmative votes.

Councilman Weinstein made a motion to open the public hearing for the 2023 Municipal Budget, seconded by Councilman Atlas. Said motion was carried unanimously. No one from the public came forward. Councilman Weinstein and Mayor Raymond expressed appreciation to CFO Rich Mondelli and the governing body members for their efforts to present a budget with no tax increase for the residents. Councilman Weinstein made a motion to close the public hearing for the 2023 Municipal Budget, seconded by Councilman Atlas. Said motion was carried unanimously. Mayor Raymond announced that a vote on the budget would be taken at a subsequent meeting.

Council President Floria-Callori provided a history of the cell tower project and bid process. VCOMM representative Dominic Villecco provided an overview of the tower construction project and leasing opportunities which would result in improvement of cellular service in the Borough and revenue generation from cellular providers. Councilman Atlas thanked Council President Floria-Callori for his commitment to finding a solution to improve cellular service and provide better safety for residents at no cost to the Borough. Councilman Rees requested construction plans for the stealth monopole installation and expressed concern for public opposition. Councilman Floria-Callori noted that the Planning Board would be considering the application for a courtesy review during which an opportunity for public comment would be availed. He confirmed that public outreach and education will be planned.

Councilman Tilton voted no. Said motion was approved with five (5) affirmative votes and one "nay" vote from Councilman Tilton.

Helen Feinberg, 115 Four Seasons Drive – Ms. Feinberg requested that library membership fees be waived for North Caldwell residents who join libraries in the surrounding towns.

Elliot Sommer, 143 Four Seasons Drive – Mr. Sommer requested increased enforcement for stop sign infractions at the intersection of White Rock Road and Elm Road. He requested automated deductions for water, sewer and property tax payments.

Alba Pennisi, 7 Soder Road — Ms. Pennisi requested that criminal activity updates be distributed through an emergency notification system in real time. She requested an update of the construction project at 13 Soder Road.

Council President Floria-Callori made a motion to close public comment, seconded by Councilman Kessler. Said motion was unanimously approved.

Council Commentary

Councilman Rees requested that the Borough pursue a speed limit reduction on Mountain Avenue. Mr. O'Sullivan reviewed the criteria to lower a speed limit on the County road. Chief Strodthoff would move digital speed limit signs to Mountain Avenue that were no longer needed on Smull Avenue since the speed table installation.

Councilman Kessier requested an update on the targeted completion date for PSEG construction on Mountain Avenue. Mr. O'Sullivan would request an updated schedule for trench restoration, milling and paving estimated to be done within the next 60 to 90 days.

Executive Session

Mayor Raymond announced that no further action would be taken after Executive Session and the meeting would not re-open to the public. There being no other matters to be addressed by the Governing Body at this time, this meeting be adjourned at 8:07p.m.
