Mayor and Council Regular Meeting – March 28, 2023

The Regular Meeting of the Mayor and Council of the Borough of North Caldwell was held on Tuesday, March 28, 2023. The meeting began at 6:34pm at Borough Hall and was held simultaneously via tele/video-conference.

Mayor Raymond called the meeting to order announcing that notice was provided in accordance with the requirements of Chapter 231, P.L. 1975. He provided a statement regarding the conduct of the teleconference which would allow members of the public to participate and be heard during public comment.

Roll Call indicated the following:

Mayor Raymond asked Kevin O'Sullivan to lead the Pledge of Allegiance.

#### Mayor's Report

Mayor Raymond called for a moment of silence in remembrance of the lives lost in the Nashville, TN school shooting on March 27, 2023. He announced that New Jersey Transit would be fulfilling bus service on some of the routes serviced by DeCamp. He announced the upcoming Essex County Cherry Blossom Festival.

# **Recognition of Recreation Basketball Championship Teams**

Mayor Raymond and the Borough Council recognized the Recreation and Travel Basketball championship team members and coaches for the 2022-2023 season.

### Citizens to be Heard

Alba Pennise, 7 Soder Road – Ms. Pennise thanked the Police Department for their service and requested that alerts be sent to residents during police chase/search activity so that residents are aware to stay indoors. Council President Floria-Callori reminded residents to lock their vehicle doors, remove key fobs from vehicles and sign up for CivicAlert notifications.

Eddie SanGiacomo, 32 Beachmont Terrace – Mr. SanGiacomo asked about consequences for vehicle thieves. Chief Strodthoff noted that the NCPD follows State laws. Councilman Tilton provided some statistics on North Caldwell arrests and announced the local legislators' efforts to appeal for harsher consequences for offenders. Council President Floria-Callori described some of North Caldwell's efforts to thwart the motor vehicle thefts and other crimes.

**Ordinance O-3-2023:** Councilman Atlas read and opened the public hearing for Ordinance O-3-2023 An Ordinance Authorizing the Borough of North Caldwell to Execute a Deed of Consolidation for Certain Property Located at Block 606, Lots 1.02, 1.03, 1.04, 1.05 and 1.06 in the Borough of North Caldwell.

Robert James Bennet, 75 Mountain Avenue – Mr. Bennett referred to the intention of the Open Space referendum in 2019 through which the subdivided lots would not be sold. He asked that the voters' wishes to maintain the Walker property as a park be honored.

Nick Walker, 198 Westville Avenue, West Caldwell – Mr. Walker, grandson of Woody and Carleigh Walker, presented his grandparents' intention for the Borough to maintain the property as a park for all residents to enjoy. He asked that the subdivided lots be consolidated to maintain the tranquility and character of the property.

Beth Shapiro, 8 Tanglewood Road – Ms. Shapiro stated her support for honoring the referendum results by maintaining the 17-acre parcel in its entirety for use by all residents.

Councilman Atlas stated his support of the ordinance which would allow for improving the property as a park with walking paths and footbridges as envisioned through the referendum.

Councilman Rees stated his understanding that the park was intended to encompass the entire 17-acres.

Councilman Floria-Callori asked Borough Engineer Mark Katyriniak for estimated deed submission and NJDEP permitting timelines. Mr. Katyriniak stated that following the lot consolidation, permit application would be advanced to the NJDEP with an estimate of 90-120 days for a decision to be rendered.

Councilman Atlas made a motion to close the hearing and adopt Ordinance O-3-2023 An Ordinance Authorizing the Borough of North Caldwell to Execute a Deed of Consolidation for Certain Property Located at Block 606, Lots 1.02, 1.03, 1.04, 1.05 and 1.06 in the Borough of North Caldwell. Said motion was seconded by Councilman Tilton and carried unanimously with five (5) affirmative votes.

No comments were received from the public or governing body. # **Public Safety**

Councilman Tilton presented the Police Department Public Safety and Detective Bureau Reports for February 2023 during which 870 calls were placed to Dispatch and 62 summonses were issued. He reminded residents to keep their homes and cars locked and to remove valuables from vehicles.

Councilman Tilton presented the Fire Department Public Safety Report for February 2023 during which 12 responses to calls were completed. Mutual aid was received from Fairfield Fire Department for a fire on Coney Road. Councilman Tilton announced the annual Pancake Breakfast scheduled for Sunday, June 4, 2023.

#### **Public Works**

Councilman Rees presented the DPW Monthly Report for February 2023 during which pipe, catch basin repairs were completed. Lead pipe replacement planning is ongoing. Topsoil, sod and conduit were installed at Firemen's Field in preparation for Opening Day.

Councilman Rees presented the Construction Permit Activity Report for February 2023 during which 43 permits were issued.

The Animal Control report was tabled until the following month.

#### **Recreation**

Councilman Kessler presented the Recreation Director's Report for March/April 2023. He thanked the basketball coaches for volunteering during the season and congratulated the championship teams. He announced the next Seniors Meeting scheduled for April 5, 2023 and the Spring Spectacular and Easter Egg Hunt on April 4, 2023. Councilman Kessler welcomed residents to participate in Earth Day weekend events including a scavenger hunt. He announced the opening of registration for pool membership and open employment opportunities for summer positions. Councilman Kessler extended his appreciation to the Department of Public Works for their efforts to improve Camp Wyanokie in advance of the camp season.

Councilman Kessler provided an update on Firemen's Turf Field improvements for which a soft-opening was scheduled for April 2<sup>nd</sup> with the official opening and ribbon-cutting ceremony scheduled for Baseball/Softball Opening Day on April 22<sup>nd</sup>.

Quarterly Newsletter – Councilman Kessler requested final comments from the Council on the quarterly newsletter draft prior to distribution on Thursday, March 30<sup>th</sup>.

He thanked DPW and the Recreation Department for their assistance with the event. He thanked Mr. O'Sullivan for his help with the Women's History Month proclamations.
