RECONSTRUCTION OF THE NORTH CALDWELL COMMUNITY POOL 141 GOULD AVENUE, NORTH CALDWELL, NJ

The work to be performed includes the furnishing of all labor, materials and equipment necessary to complete the work as shown on the drawings and described in the specifications. The work in this contract includes the reconstruction of the main pool which consists of construction of two new reinforced concrete walls within the existing pool; new interior quartz plaster finish, including depth markers, racing lanes, end wall targets, waterline, acuity lines, and warning line; new deck equipment, including ladders, starting platforms, diving board platform, racing lane dividers, divider reel, safety rope, rails, winter cover, handicapped lift, lifeguard chairs, backstroke flags and stations; and start-up and balancing of the operating systems. Work also includes reconstruction of the Spray Pad / Wading Pool consisting of a new circulation system, including drains, gutters and returns; new interior quartz plaster finish, including entry ramps and depth markers; new deck equipment, including features and bases, and handicapped accessible handrails; and start-up and balancing of the operating systems. The work in the two pool areas also includes new plumbing, including floor drains, clean-outs, piping and vents; electrical work for a new certified bond loop; balancing the pool chemistry; start-up of all systems; winter shut-down; and other incidental work.
