APPLICATION FOR MINOR SUBDIVISION

Mr. Vincent Lapone 77 Grandview Avenue North Caldwell, NJ 07006 Block 1900, Lot 9

It was noted that this applicant previously made application for Major Subdivision approval with variances and was denied. The current application has been revised and the applicant now seeks Minor Subdivision approval with no variances.

ORDINANCE O-1-18

Ordinance O-1-18, An Ordinance of the Borough of North Caldwell, County of Essex, State of New Jersey, Amending the Zoning Ordinance of the Borough of North Caldwell, Chapter §107-19 "Prohibited Uses" was introduced by the North Caldwell Council on January 30, 2018 and a public hearing is scheduled for February 27, 2018. The Ordinance proposes prohibition of the sale of marijuana and paraphernalia in the Borough of North Caldwell. In accordance with N.J.S.A. 40:55D-26, this Ordinance was referred to the Planning Board for review. After review and discussion, the Board authorized the Board Secretary to advise the Mayor and Council that the Ordinance is acceptable but to suggest that the second whereas paragraph be amended by either adding to or replacing "security purposes" with "health and safety".

2018 PERIODIC MASTER PLAN REEXAMINATION

A draft copy of the 2018 Periodic Reexamination of the Master Plan, Borough of North Caldwell, New Jersey, prepared by Burgis Associates, Inc., dated January 11, 2018 was previously distributed to Board members.

Distributed at this meeting was a document prepared by Mr. Dusinberre titled North Caldwell Planning Board Master Plan Review and a review memorandum prepared by Mr. Zichelli, dated February 5, 2018.

Discussion was had concerning the Board's review of the Reexamination Plan and the requirement for a public hearing. It was decided that each Board member would provide comments to the Board Secretary and Attorney for organizing and forwarding to Burgis
