WORK WILL INCLUDE THE REMOVAL AND REPLACEMENT OF PIPE, DRAINAGE WORK, SELECT REMOVAL AND REPLACEMENT OF SIDEWALK/CURB, HANDICAP RAMPS AND THE MILLING AND PAVING OF:

BYRON ROAD (12 BYRON ROAD TO PARK AVENUE) PARK AVENUE (ENTIRE LENGTH) TANGLEWOOD ROAD (ENTIRE LENGTH) LONGVIEW AVENUE (INTERSECTION OF TANGLEWOOD ROAD) GLENVIEW ROAD (ENTIRE LENGTH)

PLEASE BE ADVISED THAT DRAINAGE AND CURB WORK WILL START ON OR ABOUT FEBRUARY 17, 2023 (WEATHER PERMITTING)

CONSTRUCTION WILL START WITH THE PROPOSED PIPE AND DRAINAGE WORK NEAR THE INTERSECTION OF PARK AVENUE AND BYRON ROAD ALONG WITH SELECT REMOVAL AND REPLACEMENT OF SIDEWALK/CURBS. THE ANTICIPATED TIME FRAME FOR THIS INITIAL WORK WILL BE APPROXIMATELY 2-4 WEEKS TO COMPLETE. MILLING AND PAVING OF THESE STREETS WILL BE SCHEDULED LATER THIS SPRING AND ADDITIONAL NOTICES WILL BE DISTRIBUTED PRIOR TO THIS WORK COMMENCING.

CONSTRUCTION WORK HOURS ARE MONDAY THROUGH FRIDAY, FROM 8:30 AM TO 5:00 PM.

FOR THE DURATION OF THE PROJECT, THERE WILL BE SOME INCONVENIENCES THROUGHOUT THE WORK ZONE. HOWEVER, EVERY EFFORT WILL BE MADE TO ASSURE THAT THEY ARE KEPT TO A MINIMUM.

AS WITH ALL CONSTRUCTION PROJECTS, PLEASE PROCEED WITH CAUTION WHILE TRAVELLING THROUGH THE WORK ZONE.

DURING THE PIPE AND DRAINAGE WORK AROUND THE INTERSECTION OF PARK AVENUE AND BYRON ROAD, THE ROADWAY WILL BE CLOSED AND ON-STREET PARKING WILL BE PROHIBITED WHILE THIS WORK IS IN PROGRESS. IF YOU INTEND ON UTILIZING YOUR VEHICLES DURING THIS WORK, PLEASE REMOVE FROM YOUR DRIVEWAY BY 7:30 AM. TO AN ADJACENT STREET. ACCESS TO YOUR STREET WILL BE ALLOWED AT THE END OF EACH WORKING DAY.
